- Protecting biodiversity is important for both practical and moral reasons 480
- The field of conservation biology arose in response to global biodiversity losses 481
- Conservation biology is a value-based discipline 481

**22.2 Declining Biodiversity 482**

- The rate at which Earth is losing species is accelerating 482
- Extinction is the end point of incremental biological decline 483
- Earth's biota is becoming increasingly homogenized 484

**22.3 Threats to Biodiversity 486**

- Habitat loss and degradation are the most important threats to biodiversity 486
- Invasive species can displace native species and alter ecosystem properties 487

Overexploitation of species has large effects on ecological communities 488

Pollution, climate change, and disease erode the viability of populations 489

**22.4 Approaches to Conservation 491**

- Conserving current genetic diversity enables future evolution 491
- Demographic models can guide management decisions 492
- Ex situ conservation is a last-resort measure to rescue species on the brink of extinction 493
- Legal and policy measures support biological methods of protecting species and habitat 494

**22.5 Ranking Species for Protection 495**

- The rarest and the most rapidly declining species are priorities for protection 495
- Protection of surrogate species can provide protection for other species with similar habitat requirements 496

A landscape is a heterogeneous area composed of a dynamic mosaic of interacting ecosystems 504

Landscape patterns affect ecological processes by regulating movement of elements and organisms 507

Disturbance both creates and responds to landscape heterogeneity 508

#### 23.2 Habitat Fragmentation 510

Fragmented habitats are biologically impoverished relative to intact habitats 511

The matrix between habitat fragments varies in permeability 512

Edge effects change the physical environment and species abundances 513

Fragmentation alters evolutionary processes 514

#### 23.3 Designing Nature Reserves 514

Core natural areas should be large and compact 515

Core natural areas should be buffered by compatible land uses 516

Corridors can help maintain biodiversity in a fragmented landscape 517

Ecological restoration can increase biodiversity in degraded landscapes 518

#### 23.4 Ecosystem Management 518

Approaches to managing natural resources have become more collaborative over time 518

Ecosystem management sets sustainable goals, implements policies, monitors effectiveness, and adjusts as necessary 519

Humans are an integral part of ecosystems 520
